### After Years of Persecution, Ms. Hu Suhua Dies in Custody in the Hohhot Police Department

(Clearwisdom.net) Ms. Hu Suhua was arrested many times and sent to forced labor camps twice after the persecution of Falun Gong began in 1999. Her husband divorced her under tremendous pressure from the authorities. Ms. Hu had to leave her hometown and live in Hohhot City in order to avoid arrest. Before her death, she was followed by the police, and her rental home was ransacked. Ms. Hu died in custody in the Hohhot City Police Department around March 4, 2010.

In 2000, Hu Suhua was arrested and sent to Hohhot City Women's Forced Labor Camp. She was handcuffed to a bed for 25 days in a position that made it impossible to stand up, sit, or lie down. Her feet and legs became severely swollen. The other prisoners had to help her use the chamber pot. In May 2001, Ms. Hu refused to write an article criticizing Falun Dafa, so the guards handcuffed her to the bed again for 38 days and also starved her.

On July 2, 2001, Ms. Liu Zhenyu, 25, talked to the prisoners about the persecution of Falun Gong. The guards shocked her with an electric baton and beat her. Ms. Hu tried to reason with them, but the guards beat her, shocked her with electric batons, and whipped her with leather belts. When they were exhausted, the guards ordered prisoners to continue beating Ms. Hu. She was covered with wounds and passed out three times.

On November 7, 2001, Ms. Hu went on a hunger strike to protest the imprisonment and abuse. She was beaten, and force-fed highly concentrated salt water. The guards handcuffed Ms. Hu in a cell without heat for two weeks. She was handcuffed to a metal window frame with her hands behind her back, and only the tips of her toes touching the floor. The guards did not let her use the toilet.

On June 3, 2006, officers from the Chifeng City Police Department arrested Ms. Hu again. They beat her, tied her hands behind her back with wire and dragged her into a vehicle. After being detained for 15 days, Ms. Hu was taken to Masanjia Labor Camp in Liaoning Province. She was released the next day, but had to leave home to avoid being arrested again. Ms. Hu recently died in custody in the Hohhot City Police Department.

### Police Conduct Forced Abortion on Ms. Wu Junfen

(Clearwisdom.net) When Ms. Wu Junfen of Handan City, Hebei Province went home to visit her father in July 2008, she was arrested by the police because she practices Falun Gong. She was over four months pregnant at the time. The police and birth control agency personnel took her to a hospital against her will. They handcuffed her hands and feet and injected her with drugs to induce an abortion, so that they could send her to a labor camp. Fourteen days later, the police took Ms. Wu to the Hebei Province Women's Labor Camp to serve two years of forced labor. Ms. Wu is currently under persecution at the Shijiazhuang Women's Labor Camp.

Falun Dafa, also known as Falun Gong, is a practice for benefiting physical health and elevating the mind. Introduced by Mr. Li Hongzhi in China, the practice consists of five gentle exercises including meditation, and diligent effort on the part of practitioners to follow the universal principles of Truthfulness-Compassion-Forbearance in daily life. Although the practice originated in China, today it is practiced throughout the world by people of all races and walks of life. ## Promoting Falun Dafa in Gdansk, Poland

She raised her arms in the "wheel holding" stance (Exercise 2) for ten seconds and said, "I clearly felt an electric current going through my arms." After she expressed a desire to join one of the free exercise classes, a practitioner gave her the local group practice site contact. As she walked away, the woman repeatedly said, "Falun Dafa is great!"

A mother with two children asked if young kids could learn the exercises. When the practitioners said yes, the mother let her children join the group to learn the meditation exercise. The young kids sat up straight for a long time in the cold weather.

## Rally to Support 70 Million People Who Have Quit the Chinese Communist Party

(Clearwisdom.net) On March 28, 2010, the French Global Service Center for Quitting the Chinese Communist Party (CCP) held a rally at Human Rights Square (Esplanade des Droits de l'Homme) at the Palais de Chaillot in Paris. The rally called on people from around the world to support the seventy million brave Chinese people who have chosen to quit the CCP and its affiliated organizations. The rally broadcast the content of U.S. House Resolution 605, which was just passed by the United States Congress [calling for an end to the persecution of Falun Gong], in French, English and Chinese, and exposed the Chinese communist regime's crimes in the persecution and torture of Falun Gong practitioners.



Since the Chinese *Epoch Times* newspaper published *The Nine Commentaries on the Communist Party*, exposing the crimes of the CCP, more and more Chinese people have been quitting the CCP. The Service Center provides information near the Eiffel Tower and helps tourists from China to quit the CCP. Cheng, a volunteer for the Service Center, said that people quit the CCP every day. At times, over 100 people per day quit the party and its affiliated organizations.

I became a taxi driver, taking others everywhere. The changes in me are amazing. Master Li and Falun Dafa have given me a second life.
